UOL is a Federation of 17 member institutions (e.g. London School of Economics, King's College, University College London, Goldsmiths's, etc).

Many Nobel Prize Winners, Presidents, Prime Ministers, business Leaders, etc are alumni of UOL and its member institutions.

Ahead of its time, UOL was revolutionary & broke tradition, being the first British university to open its doors to people from different religious beliefs & later to women.

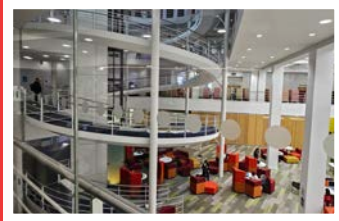

LSE offers one of the world's largest **Summer Schools**, with an exciting range of **courses** in social sciences, economics, law, and other related fields. 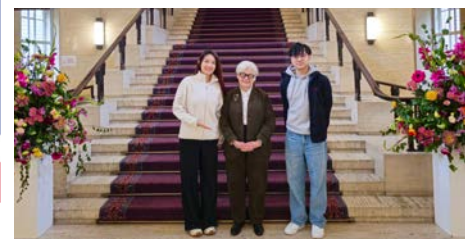

EMFSS students are welcome to study their final year at the famous **LSE**. Application can be made via Study abroad at **LSE**, The General Course.

65% OF ALL THOSE AT THE SCHOOL COME FROM OUTSIDE THE UK

A year at **LSE** is more than just a year of study at one of the world's most renowned universities. It's a year to discover London; a year to discover new opportunities, new friends and new horizons. But more importantly, it's a year to discover yourself. Quite simply, it's a year that will change your life.

Students undertaking an in-person University of London Programme with academic direction by **LSE** may apply for entry after just one year of study but will be required to obtain first year grades of at least 60 % in three courses and 40% in a fourth.

Applications can be submitted online, free of charge. They are considered from January 2025 onwards and will continue to be accepted until 31 July 2025, or until all the available places have been filled, whichever is the sooner.



45% OF THE SCHOOL'S STAFF ORIGINATE FROM COUNTRIES OUTSIDE THE UK

The tuition fee for all students applying directly to the **General Course** in 2025/26 is likely to be £28,600 for the full year. It does not cover accommodation or living costs which must be budgeted separately. We estimate that the cost of living in London for a year will be around £15,500.

University housing is guaranteed to all **General Course** students who apply for it before the deadline. John C Phelan **General Course Scholarships** and International Students House Accommodation Scholarships are available to students in financial need.

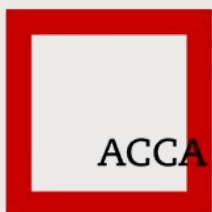

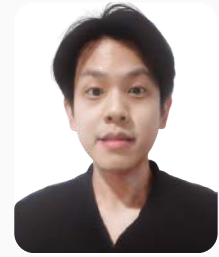

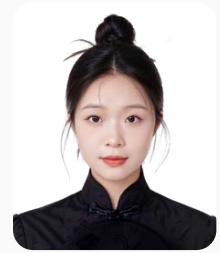
